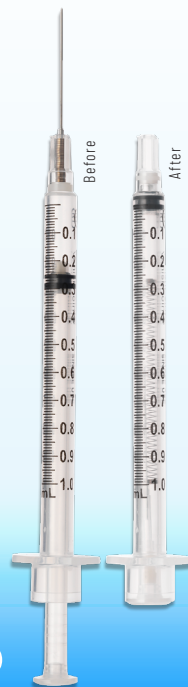

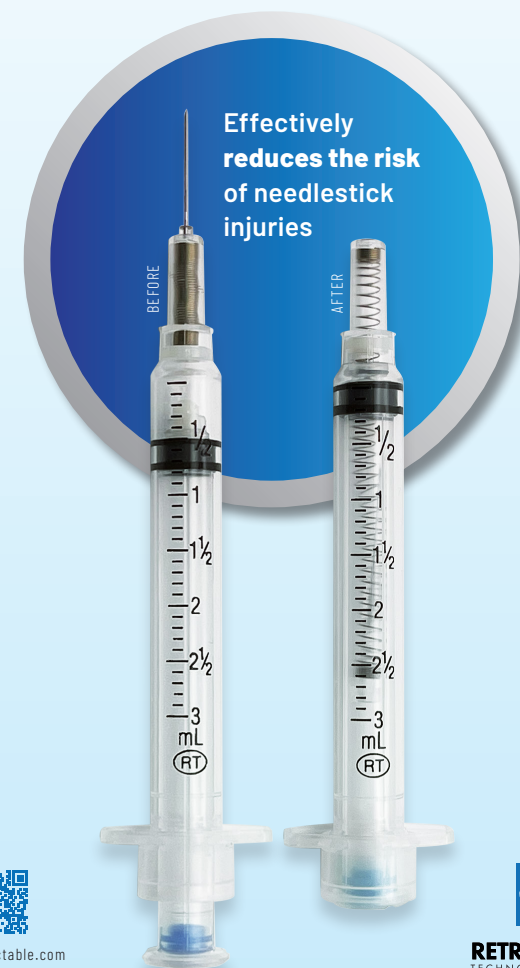

Dispose of syringe in an appropriate sharps container.



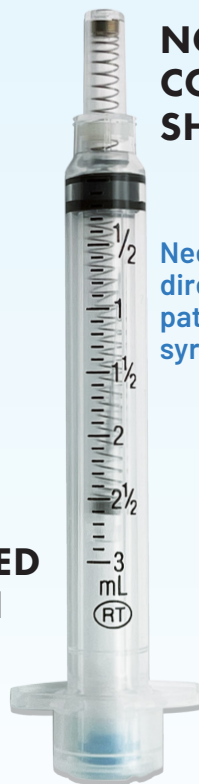
